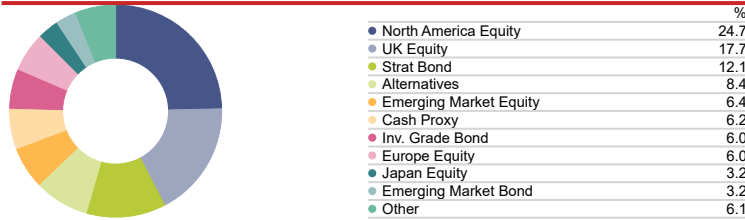

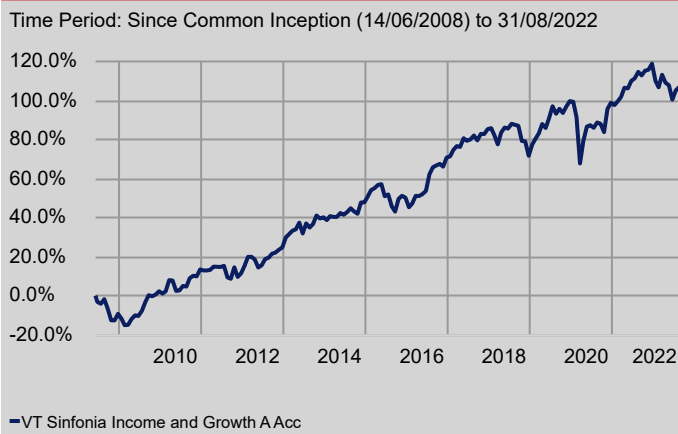
Tactical Asset Allocation
